The Islamic Human Rights Commission: Who We Are, What We Do and What We Have Done

The Islamic Human Rights Commission was set up in 1997 by a group of activists whose vision was to utilise their experience in human rights work through the medium of an openly Islamically oriented and led organisation.

IHRC was the first of its kind, and remains a leader in its fields of human rights campaign, research and advocacy. Founded at a time when Islam and Muslims were continually berated for violating human rights, IHRC took up the standard of faith to argue that in fact the opposite was true. Islam, it argued gave everyone regardless of their background basic rights, and in the modern world, it is Muslims who bear the vast

Whilst advocating for everyone, IHRC's work reflects the overwhelming prejudice, hostility and violence that face Muslims world-wide on a daily basis.

Some of our projects include campaigns for long term prisoners of faith - i.e. those held for their religious convictions. Our first major success in this field was the release of Mu'allim Ibraheem Al-Zakzaky who was imprisoned in Nigeria under the former military junta. He and almost a thousand of his supporters were released after a long running IHRC campaign brought his case to international attention. Since then IHRC's campaigns have helped secure many

We have just opened a legal advocacy section called IHRC Legal and aim to provide immigration and employment advice from our inhouse solicitor.

IHRC has consultative status with the United Nations. Our work has received widescale coverage in main-

stream and alternative media, and many of our officer are also commentators who write for and participate in many media outlets.

Our reports, books, briefings, videos, TV shows and films have been launched at many places including the House of Lords, and at the World Conference Against Racism in South Africa, which IHRC attended in 2001 with a thirteen strong

team including three rabbis from Neturei Karta, the anti-Zionist Orthodox Jewish movement. Our research work on issue such as hate crime monitoring, theory and statistics, Guantanamisation of society, Islamic notions of rights, decolonising narratives and liberation theology has provided invaluable resources for all those seeking to change the world to a better place.

We also run an on-line bookshop (shop.ihrc.org) and a small bookshop and two gallery spaces in London, which regularly host talks, screening and exhibitions. We work with local, national and regional organisations to promote shared aims. Together with Citizens International in Malaysia we hold the secretariat of the Universal Justice Network, a coalition of NGOs working towards social justice around the world.

This is just a taste of our work. This brochure highlights our fundraising event, the Islamophobia Awards, in the hope that you too will be inspired to act upon the Islamic command to rise up in defence of the weak and the oppressed, whoever they are and whosoever oppresses them.


As ever the night will also include a lavish gala dinner and a fundraising auction where we hope we can once again persuade you to dig deep and help replenish our coffers.

# Speakers and perfomers

#### **Khaleel Muhammad**

Khaleel Muhammad is a popular nasheed artist whose soulful voice and dynamic stage performances have earned him international renown.

Khaleel has appeared at the GPU, Islam Expo and Eid in the Square celebrations and also collaborated, as well as co-wrote, the 'Feed the World, Feed The Fasting' charity song for Muslim Aid and 'Artists United for Haiti' for Islamic Reflief.



#### Professor Salman Sayyid

Professor Sayyid has been the Director of the Centre for Ethnicity and Racism Studies at the University of Leeds since 2007, as well as the Reader in Rhetoric and Postcolonialism and Racism Studies since 2008. Professor Sayyid has worked in a number of UK Universities including the

University of Salford, and the University of East London, and in 2007 was a Distinguished Visiting Scholar to the International Islamic University, Islamabad. His teaching interests

have focused on racism, postcolonialism, critical theory and 'political Islam', and he has taught, supervised and been an examiner at postgraduate level for many years. Professor Sayyid's research interests encompass ethnicity and racism; the relationship between culture and politics; postcolonial political studies, and in particular, the way in which the analysis of postcolonial conditions inform and affect so-called 'mainstream' political and social processes and structures.

He has written extensively and his most recent works include: Thinking through Islamophobia: a global perspective (C Hurst & Co Publishers, London, 2010), and Recalling the caliphate: decolonization and world order (Columbia University Press, New York, 2010). He is currently a member of the Editorial Advisory Board of the Social Movements Journal, and has presented keynote speeches at various national and international conferences.





#### **Melissa Melodee**

Melissa Melodee is an independent music artist from London, UK. She is a singer/songwriter/rapper/poet. She plans to release a Nasheed Album in the near future. Melissa Melodee performs with the Hip Hop Shakespeare Company (HHSC) founded by Mobo Award winning Hip Hop artist Akala.

#### **Aamer Rahman**

Aamer Rahman is an acclaimed Australian comedian. TV personality, writer and activist. As well as doing stand-up comedy, Rahman has written for television, including two seasons of the Astra awardwinning 'Balls of Steel Australia'. As one part of the comedy duo Fear Of A Black Planet, Rahman was the focus of a TV episode of 'Australian Story', viewed in Australia by nearly one million viewers. The show documented their lives in Australia. as well as their debut run at the Edinburgh Fringe Festival and their sellout gig in London.

Born in South Africa where he studied graphic design, he moved London in 1999 to work in the creative industries – during this time he also studied the art of the recitation of the Quran.

They openly promote concepts like Genocide Memorial Day; they are at the forefront of many events supporting the oppressed people of Palestine; they challenge the continued and unjustifiable existence of places like Guantanamo

Bay, and otherwise speak up for those with marginalised voices as well as those with no voice at all.

The existence of groups like the IHRC is important as there will never be peace and understanding without dialogue and an open space where we can all feel comfortable enough to challenge each other's beliefs and thought processes without fear of recourse to recrimination. The provision of that space and service is one of the key strengths of the IHRC.





### Research, Campaigns and Advocacy

#### Research

The research section at IHRC is a leader in studies on Islamophobia / anti-Muslim hatred and discrimination. In addition to country reports, it has developed an acclaimed body of academic work that provides statistics of experiences of hatred in various countries. IHRC has focussed on many countries, but has focussed on the UK, France, the Netherlands, Denmark, Belgium, the USA and Canada, with more research slated for Australia in the coming year.

Aside from its books and reports on these issues, the IHRC research team is also involved in publishing papers and books, and producing films and documentaries. From themes such as Extradition to Decolonising Knowledge, the Research department works with diverse researchers, academics, filmmakers and journalists making unheard voices and little known issues accessible to a wider audi-

#### **■** Campaigns at IHRC

This department is responsible for the many public campaigns that have brought the IHRC to national and international prominence. Amongst other things, it currently focuses on Bahrain, Bangladesh, Myanmar, Palestine and political prisoners in the USA. By encouraging people to take part in campaigning whether through letter writing, attending vigils or other means, Campaigns at IHRC works towards empowering people to stand up for justice.

#### **■ IHRC Advocacy**

IHRC Advocacy department has been working with members of the community who have faced discrimination in various aspects of their lives. From prayer space at work to hijabs at school and prison discrimination, we continue to receive a broad range of cases. Our clients are mainly UK-based but we have supported British citizens in the USA, Syria and Pakistan.

Our caseworkers also do a lot of international advocacy, writing to various international bodies on behalf of clients, as well as implementing various IHRC campaigns.

IHRC also sends Eid packs to Muslim prisoners in London. In 2013 IHRC sent Eid packs to 1000 prisoners. The aim of the project is to create a bridge between the prisoners and the Muslim community during Eid-ul-Fitr and Eid-ul-

#### **IHRC Legal**

IHRC Advocacy would like to announce the launch of its new project: IHRC Legal.

In recent years we have seen the government make cutbacks to legal aid leaving large numbers of people unable to pursue their claims because they lack the means to secure their rights.

IHRC Advocacy has set up its new legal wing to provide high quality subsidised legal services. The intention of asking for a contribution from our clients is to make the project sustainable in the long term. IHRC hopes to cover the remainder of the cost through fundraising and creating partnerships with various grantmaking bodies. Where individuals are unable to pay, IHRC hopes to fully subsidise the services provided to them.

IHRC Legal will focus on providing services in employment and immigration. Our primary focus will be discrimination in employment as well as helping the vulnerable secure their immigration status in the UK.

With the support of the community we hope to see this project grow so that in the future we may be able to support people to challenge police abuses as well as legally challenge government policies that negatively affect the Muslim community.

#### **Know Your Rights Project**

We launched the first of our Know Your Rights Leaflets (KYR) in October 2013 covering people's rights when they are stopped at ports or airports under Schedule 7 powers.

The KYR leaflets provide information about the powers available to the police as well as people's legal rights. The information is available in pocket sized leaflets which people can carry with them, or as a downloadable app for their mobile phones.

We are planning to launch a number of KYR leaflets this year covering employment, immigration, and police stop and searches.

As part of the project we are also now offering KYR workshops. The workshops will be offered to community groups / mosques / ISOCs who wish to learn more about their rights. Our advocates will be travelling up and down the UK holding these workshops. Look out for a workshop near you!
