Re: Interim Manager appointed to Islamic Centre of England Limited

Thank you for your letter to our Chairman, dated 31 May 2023, in which you have raised concerns about the Charity Commission's decision to appoint an Interim Manager ('IM') to the Islamic Centre of England Limited ('the Charity'). As the Director responsible for this work, I have been asked to respond. I note that the letter has been signed by thirty-five individuals and organisations. Please ensure that all the signatories have sight of this letter.

As you are aware the Commission opened a statutory inquiry ('the Inquiry') into the Charity¹ on 14 November 2022 before later appointing an IM on 4 May 2023².

I am confident that the appointment of the IM to the Charity was in accordance with our statutory duties and functions and our obligations as an independent public body. Our decision in this case was based on regulatory concerns assessed against our published framework. It is a temporary, protective measure. The Order appointing the IM explicitly makes clear that the trustees of the Charity retain responsibility for the proper provision of religious services to the Charity's beneficiaries – this remains the case.

We need to act robustly where serious concerns about a charity exist, so that the public, and the charity sector itself, can have confidence in what it means to have charitable status. In this case I am confident that appointing the IM was the correct thing to do to address serious issues within the Charity that need to be resolved. All IMs are appointed in line with our guidance, and must work in accordance with the published code of conduct.
